

IMPORTANT SAFETY TIPS

- Never drive your vehicle with the cap door(s) open.
- Do not use the product for passenger occupancy while the vehicle is in motion or while the engine is running.
- Factory installed Yakima® racks on SnugTop fiberglass caps have a load limit of 150 lbs.
- Bolt plate reinforcements (available from SNUGTOP) may be necessary for aftermarket rack systems.
- Contact your auto insurance company to make them aware you have added a SnugTop cap to your vehicle.

LIFETIME PAINT & STRUCTURAL WARRANTY

STRUCTURE

Truck Accessories Group, LLC d/b/a Leer Group warrants you, the original retail Purchaser, that for as long as you own your SNUGTOP® brand recreational fiberglass truck cap, installed by an authorized SNUGTOP Dealer on the original vehicle, that it will be free from defects in material and workmanship of the fiberglass structural material below the color surface.

*Model exceptions do apply, see list below.

PAINT

LEER Group warrants you, the original retail Purchaser of a SNUGTOP brand recreational fiberglass truck cap or aluminum truck cap installed by an authorized SNUGTOP Dealer on the original vehicle, that the exterior paint will not abnormally fade or peel due to material or workmanship more rapidly than the original paint finish on the original vehicle on which it was installed, for as long as you own your cap.

*Model exceptions do apply, see list below.

HARDWARE

Hardware components of doors and windows including Center High-Mount Stop Lights (CHMSL), locks, latches, factory-installed accessories, gas props, but excluding glass and light bulbs, shall be warranted for one (1) year from date of purchase.

The warranty period begins on the date the cap is purchased by the first retail buyer (original purchaser) or put into use, whichever is earlier.

LEER Group warrants to the original purchaser for the original vehicle that it will, at its option, either repair without charge the items covered by this warranty, or replace the original product with a product of equal value or model, based on current model availability. This warranty specifically excludes damage due to accidents, misuse, alterations, improper installation, or lack of proper care and maintenance as listed in this warranty.

LEER Group suggests that you visit an authorized SNUGTOP Dealer once a year to have clamps and other hardware checked and adjusted. There may be a charge for these adjustments.

*MODEL EXCEPTIONS TO THE STRUCTURE AND PAINT WARRANTY:

1. Commercial Fiberglass (SnugPro Cab-Hi, SnugPro XV, SnugPro Hi-Liner, SnugPro Sport Hi-Liner & CHU): 5-Year Limited Warranty on the fiberglass structure.
2. Commercial Aluminum (UT PRO): 5-Year Limited Warranty on the welded aluminum frame structure and exterior paint fading/peeling.

EXCLUSIONS FROM LIMITED WARRANTY:

1. This limited warranty does not apply to accessories installed by anyone other than the factory.
2. This limited warranty does not apply to any fading or peeling of the painted surface that may result from misuse, impact, or normal wear and tear.
3. This limited warranty does not apply to damage resulting from operating your vehicle with the cap door open.

4. This limited warranty does not apply to damage due to accidents, misuse, off-road driving, alterations, acid rain, airborne fallout (chemicals, tree sap, etc.), salt, road hazards, hail, wind storm, floods, and other natural disasters, lack of proper care and maintenance or normal wear and tear. Paint wear and abrasions on the truck bed rails and elsewhere where the cap contacts the truck is considered normal wear and tear, and is expected with the installation and use of any truck cap; and is the sole responsibility of the pick-up truck owner.
5. This limited warranty does not apply to improperly installed caps.
6. This limited warranty does not apply to glass breakage or light bulbs.
7. This limited warranty does not guarantee fit to any non OEM surface.

All repairs shall be performed at the premises of an authorized SNUGTOP Dealer, or at a LEER Group manufacturing facility. Purchasers making a claim under this warranty shall deliver the truck cap to an authorized SNUGTOP Dealer. Dealer may charge a nominal labor charge for removal of cap. LEER Group does not authorize any person to create, on its behalf, any obligation with respect to the truck cap except as provided in this limited warranty. LEER Group does not warrant the merchantability or fitness for any particular purpose, whether written or implied. When LEER Group Warranty Department authorizes complete repaint of cap by an independent paint shop under SNUGTOP warranty, it becomes the responsibility of that paint shop to warrant the paint from that point forward. Purchaser's remedy for breach of any warranty shall consist solely of repair or replacement under the terms of this written warranty. In no event shall LEER Group be liable for any consequential damages or loss arising from purchase, installation or use of the cap.

INTERNATIONAL CUSTOMERS - WARRANTY LIMITS MAY APPLY: For our valued customers outside of the United States, only an authorized SNUGTOP Dealer in the country from which you purchased your SNUGTOP brand cap is responsible for all warranty issues. Any exception is at the sole discretion of Truck Accessories Group, LLC d/b/a Leer Group and must be approved prior to any repair service or warranty claim rendered.

PROOF OF THE RETAIL PURCHASE DATE MUST BE PRESENTED AT THE TIME OF ANY CLAIM.

Only the original invoice, including serial number of the unit and the VIN from the vehicle, presented by the purchaser constitutes proof. This warranty is void without such proof. Some states do not allow limitations on how long an implied warranty will last or the exclusion of limitation of incidental or consequential rights, and you may also have other rights which vary from state to state.

This express limited warranty is the sole and exclusive warranty provided by Truck Accessories Group, LLC d/b/a Leer Group for this product. SNUGTOP does not make and hereby disclaims any and all other express or implied warranties, including but not limited to the implied warranty of merchantability and the implied warranty of fitness for a particular purpose.

YOUR NEW SNUGTOP CAP MUST BE REGISTERED TO MAKE THE WARRANTY VALID.

IMPORTANT CARE INSTRUCTIONS FOR YOUR SNUGTOP TRUCK CAP

Your SNUGTOP will give you years of trouble-free service if you follow these recommendations:

TO PROLONG THE LIFE OF THE FINISH

- To properly care for a painted surface, wash (with a mild detergent) and wax the Cap every four to six weeks with a high-quality car or boat wax.
- Do not use abrasive cleaners.
- Do not wipe painted surfaces with a dry cloth (Please wait approx. 60 days before waxing to allow for maximum cure of the paint finish).
- Do not scrape off ice and snow from your Truck Cap.

RUBBER COLLAR ONLY: Reduce paint wear by regularly keeping the area between the rubber collar and the back of the truck cab free of dust and dirt.

HOW TO CARE FOR THE PARTS ON THE CAP

- Lubricate all moving door lock parts regularly with an oil base lubricant.
- Do not use any silicone or petroleum distillate (WD-40) type spray lubricants.
- Lubricate locks, hinges, locking rods, etc. regularly.

CHECKING FOR PROPER FIT PERIODICALLY PREVENTS WEAR

- Improper tightening of j-hooks (mounting hardware) may result in excessive movement of the Truck Cap causing paint wear where the rubber seal makes contact with the truck rails and where the rubber boot makes contact with the vehicle cab. Engine and road vibrations can also cause mounting hardware to work loose.

NOTE: Contact your SNUGTOP dealer regarding the availability of products, which protect the truck surface against scuffing and/or chafing.

REMOVING AND RE-INSTALLING YOUR SNUGTOP

If your Truck Cap needs to be removed or re-installed please:

- A) follow the Installation Instructions supplied by your SNUGTOP dealer or
- B) visit your SNUGTOP dealer for assistance or
- C) visit snugtop.com for the location of your nearest dealer or a copy of the installation instructions as well as care and maintenance information.

WARRANTY – IMPORTANT

This card is to remain with the vehicle after the sale.

- Truck Caps are not designed to serve as passenger compartments.
- State laws prohibit carrying passengers in the bed of a pickup truck.
- Do not occupy the pickup truck box while the engine is running or the vehicle is moving. Serious or fatal injury may occur from collision or carbon monoxide poisoning.



- Always keep your Truck Cap doors closed while driving your vehicle.
- All mounting hardware requires regular inspection and occasional tightening. If you detect any wear or corrosion on mounting hardware, contact your SNUGTOP dealer for factory replacement parts.
- This Truck Cap is weather resistant but not weatherproof. Please take appropriate measures to ensure the safety of any items of value.
- This Truck Cap is not a 'Roll Bar'. In case of an accident, it does not provide protection to the occupants of the vehicle.
- Protect yourself and others - buckle up!
- Make other family members and additional drivers aware of these warnings.

ROOF RACK WARNINGS

- Do not load your rack in excess of the rated rack capacity.
- Loads must be secured to be properly retained in all moving and stopping conditions.
- Be careful when heavy loads are carried high as they can alter the center of gravity of your vehicle.
- Do not exceed the rated load capacity of your vehicle.
